1.141/12 TO DISCUSS THE FUTURE OF THE STREET LIGHTING MAINTENANCE FOR THE COMMUNITY.

Councillor Affleck reported that there was not much difference between the maintenance costs of NWP Power Systems and Flintshire County Council. Flintshire County Council are looking at adopting a new policy in respect of street lights with the possibility that the County Council may be adopting lights, no decision will be made until after the May 2012 Elections. Councillor Geraint Jones proposed that the Town Council take no further action in respect of future maintenance until after the Election. Members unanimously agreed.

The Clerk reported that she had received a telephone call from Mr Neville Pierce -Jenkins requesting that members give consideration to agreeing that the street lights be switched off throughout the town at midnight. After a discussion members unanimously agreed not to approve this request as switching the lights off could result in an increase in crime and dangerous for people walking along the streets, in particular with the raised steps on the pavements.

Councillor Mrs Priestly agreed to visit the location and inform the Clerk if the salt bin had been replaced.

133/11 Introduction of a Speed Limit on the A541 at Afonwen Reported that Tenders have been issued to quote for the work to be carried out on all A and B roads in the County with a requirement for them to be returned to Flintshire County Council by noon on the 20th February 2012. The project Brief contains a timescale for completion of the speed limit review by 29th June 2012. The Welsh Government guidance urges local authorities to implement any changes by 31st December 2014.
